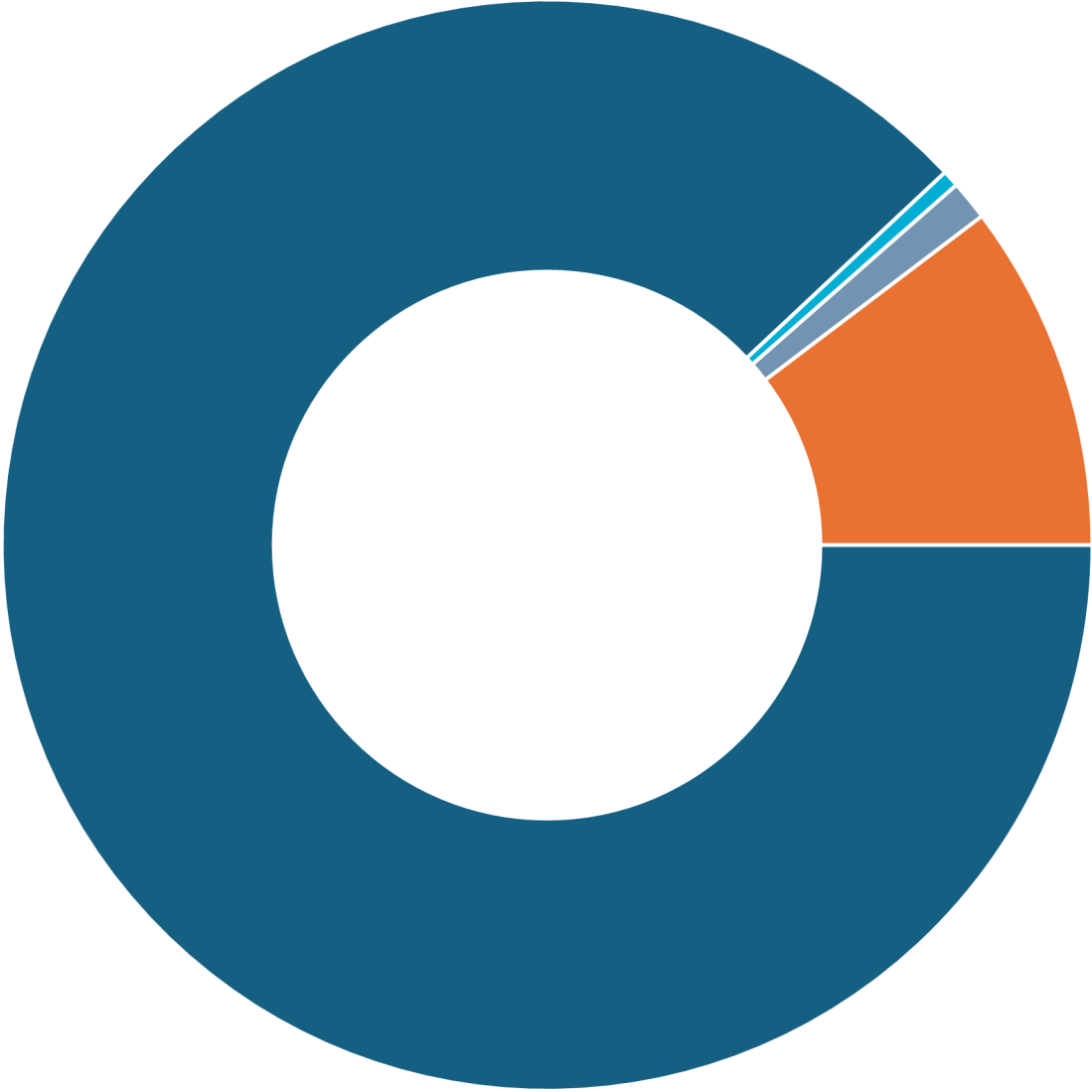

In 2025, Medicaid: State Code Derived: FL-CMS 19 received a total of 296,583 standard (non-urgent) prior authorization requests for our covered patients.

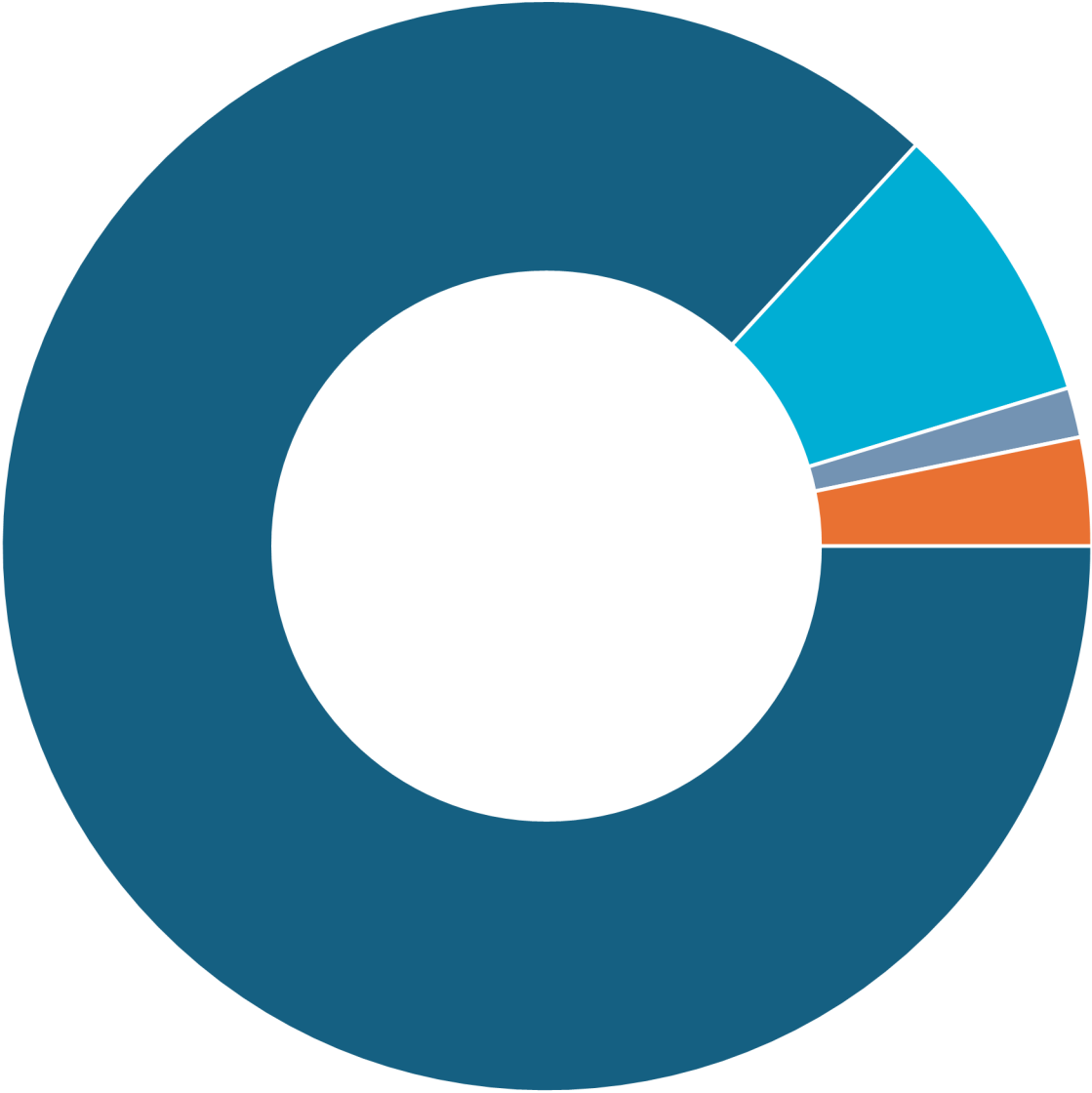
89.52% of those requests were approved:
